# The Registration Period for the Current Settlement has Ended



You will only receive a Claims Form if you completed a Registration Form.

Access to Claims forms will be either online or on paper forms.



# Frequently Asked Questions



Q: How do I participate in the settlement?

A: You must have submitted a registration form to the Claims Administrator by March 29, 2021 in order to participate in the settlement.

Q: How do I find out if I registered for the settlement?

A: You can call or email the Claims Administrator at 1-800-493-1754 or [flintwater@archersystems.com](mailto:flintwater@archersystems.com).

# Frequently Asked Questions



Q: If I registered for the settlement, is there anything else I have to do?

A: Yes, you will have to complete and submit claims forms once that process starts.

Q: Has the claims period started?

A: No. You will receive notice from the Claims Administrator either via email or mail when the claims process has begun.

# Frequently Asked Questions

Q: Are people receiving settlement money now?



A: No. No one has received any money under the settlement yet. We must go through the claims process, and the Claims Administrator must process and review these claims before any money can be paid under the settlement.

Q: Have attorneys been paid?

A: No. Class counsel has submitted a motion for attorneys fees to Judge Levy who has discretion to determine the attorney fees paid to counsel as part of the settlement.

# Frequently Asked Questions



**Q:** Will there be other opportunities for me to recover money for harm I suffered as part of the Flint Water Crisis?

**A:** Potentially. We have ongoing litigation in the class case against the remaining engineering defendants. We are hopeful that this case will be successfully resolved and provide another opportunity for monetary recovery.
